I have to thank the committee for the work that each has been doing to enable events like this one to take place. It takes time and effort behind the scenes for everything to run smoothly. Covid has certainly provided some challenges to be able to hold events but hopefully the end is in sight.

It is also great to be able to provide CQMRG merchandise to further get our name out there.

Attendances have been great, limiting factors have been the transport requirement for the site visits.

The hosting organisations have been generous in covering the costs of venues, and other items. Some of the consulting companies have also chipped in to cover costs. This has meant that we have not had to charge attendance at meetings, and subscription fees cover our web hosting costs. As with everything, costs are continually going up but we are in a sound financial position so have been able to subsidise the cost of bus from Springsure to Rolleston Mine.

At the time of writing CQMRG had a membership of 168 active members and about 179 lapsed members. Our full contact list is running at 486. Workshop registrations for 2020 totalled 106 with over 70 registrations in total for this current workshop.

Central Queensland Mine Rehabilitation Group Management Committee Nomination Form

Extract from the Charter:

VI. Management Committee
